

#### WHO WE ARE

We are a Sudanese private sector company founded in 2014 for the purpose of advance manufacturing and development of gum Arabic as such it is the only supporter of the gum Arabic producer.

The company has been established as joint venture between three companies. All three project partners have a long experience in all aspects of gum Arabic. Purchasing, processing, management and marketing. The shareholders and managers of the companies have worked in all elements of the product chain. They are focusing and aiming at the improvement of the livelihood of the local producers, population in western Sudan regions.

Our vision is that FOGA becomes a world leader in the knowledge and affairs of gum Arabic, following fair trading conditions and responsible social and environmental practices.

The company is aiming to achieve commercial success in ways that honors ethical values and respect people, communities and the natural environment by minimizing any negative environmental and social impacts and maximizing the positive ones.

We work close together with the farmers and train them on improving in several areas. Farmers are mainly based in the five regions of Darfur (the Gum belt).

Our factories in Sudan gathers the gum from the farmers, clean it and produce it. In Darfur our factories are based for cleaning, packing and powdering. In Khartoum we are establishing a spray dry factory.

To sell the product worldwide we work together with branches and agents. In Dubai and in The Netherlands branch offices are situated (see contact details) and currently in China and US we have agents with unique selling rights in their countries.

Our supervisors, managers, officers and directors share the responsibility to lead the Company according to our ambitions and commitments in both words and actions. First of all we train farmers and spread crop. We give basic and advanced training.

During the harvesting season we get the gum from the farmers and manufacture and package it to the next available products:

#### **Gum Arabic Hashab**

- a) Hand Picked
- b) Cleaned
- c) Kibbled
- d) Dust
- e) Mechanical Powder
- f) Spray Dry

#### **Gum Arabic Talha**

- a) Cleaned
- b) Mechanical Powder
- c) Spray Dry

#### **Basic Training**

Goal of this training is to update and promote understanding and practices of gun Arabic production, its natural environment conservation and its contribution on the development of local communities.

- Equipping participants with knowledge and techniques related to gum Arabic tapping, collection transportation and storage.
- Sharing knowledge and experience among participants about gum Arabic and conservation of its environments.



#### Field Training

During the field training participants see and feel how crop is made, how to handle it and how to care for the trees.

#### **Advanced Training**

The objective of this training is to contribute to promotion and development of capacities of the traditional gum Arabic producers and production systems for rehabilitation of gum Arabic trees cover and increase of gum production.

Specific objectives are:



- Equipping participants with knowledge related to the importance and potential contribution of the producers in promotion and development of gum Arabic production system.
- Provide participants with the knowledge and techniques to help improve the ways and means of production of gum Arabic.
- Identify opportunities associated with community organizational set-up including men and women in a process that can contribute to development of the producers and the production process.

#### Peace building contribution

FOGA contributes actively in the peace building within the country by giving basic training for different tribes and nomads at the same time.

#### **People migration support**

When migrants return to their home town in Darfur area and start to rebuild their lives, FOGA supports them in rehabilitating by giving crop and training how to edit the soil.
